

TRESTLE® BIKE GIVEAWAY 2026

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

1. ELIGIBILITY. The “Trestle® Bike Giveaway 2026” (the “Giveaway”) is only open to entrants who, as of the entry date, are permanent legal residents of the fifty (50) United States (excluding Rhode Island) or the District of Columbia who are eighteen (18) years of age or older at the time of entry. The Giveaway is void outside the fifty (50) United States and the District of Columbia and where prohibited or restricted by law (including in Rhode Island). Employees, officers and directors of Intrawest/Winter Park Operations Corporation (“**Sponsor**”) and its parents, subsidiaries, affiliates (including, without limitation, Intrawest Hospitality Management, Intrawest Retail Group, and Alterra Mountain Company), divisions, advertising and promotion agencies, and the immediate families (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter the Giveaway. The Giveaway, and any website pages and advertisements relating thereto, is intended for viewing only within the eligible Giveaway territory, and entrants must be present in the eligible Giveaway territory at the time they enter.

2. TIMING. The Giveaway entry period begins at 10:00 a.m. Mountain Time (“**MT**”) on **08/17/2026** and ends at 6:30 p.m. MT on **9/27/2026** (the “**Entry Period**”). Sponsor’s computer is the official timekeeping device for the Giveaway.

3. HOW TO ENTER. There are two (2) ways to enter the Giveaway:

a. TO BE ENTERED AUTOMATICALLY (Eligible Bike Lesson Participant and Bike Rental Customers): During the Entry Period, visit Trestle Bike Park (the “**Bike Park**”) and (i) take a qualifying adult bike lesson or adult coaching session, which includes Learn to Mountain Bike lessons, Private Lessons, Lesson 2 Pack, 90 Minute Pro Tips, and Specialty Clinics (excludes all child lesson products), or (ii) Rent a qualifying adult bike package, which includes ½ or full day Standard, Premium and Enduro Rental packages or Rental 2 Pack products (excludes any child or junior rental products), (“**Qualifying Customer**”) and you will be automatically entered to receive one (1) entry in the Giveaway. Eligible Qualifying Customer exclude any complimentary guests. Submitting customer information fraudulently or using automated devices is prohibited and will result in disqualification. Email communication will be sent to each Qualifying Customer entrant once entrant has officially been entered into the Giveaway. Qualifying Customer entrants will be contacted at the email address associated with their purchase solely for purposes of administering the Giveaway, including entry confirmation and prize notification. Consent to receive marketing or promotional emails is optional and not required to enter or win, and opting in or out of marketing communications will not affect an entrant’s chances of winning. Both Season Pass scans must occur during the Entry Period.

b. TO ENTER IN PERSON (Free Alternative Method of Entry): During the Entry Period, go to Trestle Bike Shop located in the Village at Winter Park and obtain an Official Entry Form (available while supplies last). Once you have fully completed the Official Entry Form by legibly hand printing all requested information on the form, and depositing the completed form in the Official Entry Form deposit box/location located at Trestle Bike Shop, you will be automatically eligible to receive one (1) entry in the Giveaway. Entries will only be accepted at Trestle Bike Shop during Trestle Bike Park’s normal business hours during the Entry Period. No facsimiles, photocopied or mechanically reproduced entries allowed. Use of any automated system to submit entries is prohibited and will result in disqualification.

c. FOR ALL ENTRIES: LIMIT: One (1) entry per person (regardless of method of entry or, if entering via qualifying lesson or bike rental, regardless of the number of scans completed during the Entry Period) or address (physical or email) in the Giveaway. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address provided will be deemed to be the entrant. Potential winners may be required to show proof of being the authorized account holder. The “**authorized account holder**” is the natural person assigned to an email address by an Internet service provider, online service provider, or other organization responsible for

assigning email addresses for the domain associated with the submitted email address. All entries, regardless of method of entry, must be received by Sponsor during the Entry Period (or during such certain dates and times within the Entry Period as expressly specified above). All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of online submission or in-person deposit will not be deemed to be proof of receipt of entry by Sponsor. All entrants and entries subject to verification prior to the awarding of a prize, as are the eligibility, age and other claims of/information provided by a potential prize winner. Entrants will cooperate with Sponsor and its representatives in connection with any and all verification activities, including, without limitation, by executing and delivering to Sponsor by the time indicated by Sponsor any verification authorization forms required by Sponsor.

4. AGREEMENT TO OFFICIAL RULES AND DECISIONS. By participating in the Giveaway, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of Sponsor (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and the winner, and the awarding of the prize), which are final and binding in all respects.

5. DRAWING; ODDS; NOTIFICATION. On or about 10/10/2026, Sponsor will randomly select one (1) potential winner from among all eligible entries received by Sponsor during the Entry Period through both methods of entry. Odds of winning the prize depend on the number of eligible entries received by Sponsor in the Giveaway. The entrant selected must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be notified by phone, mail, courier, and/or email. The potential winner will be required to execute and return to Sponsor a notarized Affidavit of Eligibility, a Liability Release, and, except where prohibited by law, a Publicity Release (an "Affidavit/Release") in the form(s) provided by Sponsor in order to claim his/her prize. The Affidavit/Release must be returned to Sponsor by the date and/or time indicated within the Affidavit/Release. If the potential winner cannot be contacted within seventy-two (72) hours of the first attempt to contact him/her, or if the potential winner fails to return the Affidavit/Release within the specified time, or if any prize or prize notification is returned as undeliverable, or if the potential winner is found to be ineligible, or if the potential winner does not comply with the Official Rules, then the potential winner may be disqualified and an alternate winner selected by Sponsor in his/her place at random from among all eligible non-winning entries received by Sponsor for the Giveaway. In such event, an alternate potential prize winner will be notified as described above and will be required to return the required documents to Sponsor as described above.

6. PRIZE. Subject to the terms and conditions of these Official Rules, one (1) prize will be awarded in this Giveaway. The approximate retail value ("ARV") of a prize is Three Thousand Nine Hundred Ninety-Nine U.S. Dollars (\$3,999 USD).

The prize consists of and is limited to one (1) Transition Patrol Alloy Eagle 70 mountain bike, Size Large (the "**Prize**"). THE PRIZE CONSISTS OF AND IS LIMITED ONLY TO THE BIKE AND OTHER ITEMS WHICH ACCOMPANY A BASE MODEL BIKE IN ITS BOX. ADDITIONAL SERVICES AND/OR ITEMS ARE OR MAY BE REQUIRED TO USE THE PRIZE, AND THOSE SERVICES AND ITEMS ARE NOT INCLUDED WITH THE PRIZE BUT MUST BE PURCHASED OR OTHERWISE OBTAINED AT THE WINNER'S TIME AND EXPENSE IN ORDER TO USE THE PRIZE. Prize must be picked up at Winter Park Resort.

Prize is nontransferable, nonassignable, nonnegotiable, and not redeemable for cash or credit. Prize must be accepted as awarded. Prize is awarded "AS IS" with no warranty, representation, or guarantee, express or implied, in fact or in law, made by Sponsor or for which Sponsor shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE AND WINNER ASSUMES ANY AND ALL RISKS OF USING THE PRIZE, INCLUDING PERSONAL INJURY OR DEATH. No prize substitutions, except by Sponsor, who reserves the right (but has no obligation) to substitute the Prize (or a component thereof) with another prize of equal or greater value (including cash) if the Prize (or a component thereof) is not available for any reason as determined by Sponsor in its sole discretion. Unused components of the Prize shall be forfeited and have no redeemable cash value. Winner is solely and fully responsible for any and all costs, fees, taxes, assessments and expenses associated with Prize award, redemption, receipt and use, including, without limitation, all federal, state and local taxes on the Prize. If applicable, winner will be issued an IRS Form 1099 for the actual retail value of the Prize. Winners waive the right to assert as a cost of winning a prize any and all costs of verification and redemption or travel to redeem the Prize. Non-compliance with any of the foregoing

and any other condition of this Giveaway may result in disqualification and forfeiture of the Prize, in which case, no consideration will be awarded.

7. PUBLICITY. Except where prohibited by law, participation in the Giveaway constitutes winner's consent to Sponsor's (and its successors' and assigns') use of winner's name, biography, likeness, voice, photographs, video, opinions, statements, hometown, state and country for promotional purposes in any manner or media (including, without limitation, online), worldwide, in perpetuity, and without further payment, consideration, notice, review or consent.

8. GENERAL CONDITIONS. Sponsor reserves the right, in its sole discretion, to terminate, modify or suspend the Giveaway if, in Sponsor's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Giveaway, or if viruses, bugs, unauthorized intervention, fraud, technical difficulties or failures or any other factor beyond Sponsor's reasonable control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Giveaway. In such event, Sponsor reserves the right (but does not have the obligation) in its sole discretion to award prizes at random from among eligible, non-suspect entries received up to the time of suspected impairment. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Giveaway or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any website or undermine the legitimate operation of this Giveaway is a violation of criminal and civil laws, and, should such an attempt be made, Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision or any other provision of these Official Rules.

9. RELEASE. By participating in the Giveaway, each entrant (or if the entrant is a minor, such minor's parent or legal guardian) forever and irrevocably RELEASES, DISCHARGES, INDEMNIFIES AND HOLDS HARMLESS Sponsor and its parents, subsidiaries and affiliates, and their respective agents, advertising and promotion agencies, affiliates, Giveaway partners and prize suppliers, and all of their respective employees, officers, directors, shareholders and agents (collectively, the "**Releasees**") from and against all losses, claims, damages, liabilities, costs or expenses (collectively, "**Losses**"), arising in whole or in part, directly or indirectly, from entrant's participation and/or entry in the Giveaway and/or entrant's award, receipt or use of any prize awarded in the Giveaway. This is a complete RELEASE and DISCHARGE of all claims and rights of each entrant against the Releasees and no action will be taken by or on behalf of an entrant with respect to any such claims and rights, it being understood that these Official Rules, including this Rule 9, shall be binding upon each entrant, and his/her successors, assignees, subrogors, insurers, heirs, next of kin, executors, representatives, and legal and personal representatives.

10. LIMITATIONS OF LIABILITY. Sponsor is not responsible for: (a) incorrect or inaccurate transcription of entry information or late, lost, stolen, unintelligible, illegible, damaged, mutilated, altered, incomplete, misdirected or postage due entries or entries received through impermissible or illegitimate channels, all of which will be disqualified; (b) technical failures of any kind, including but not limited to the malfunctioning of any telephone, computer online systems, computer equipment, website, server provider, network, hardware or software; (c) the unavailability or inaccessibility of any website or service; (d) unauthorized intervention in any part of the entry process or the Giveaway; (e) printing, typographical, electronic or human errors which may occur in the offer or administration of the Giveaway or the processing of entries; or (f) any injury or damage to persons or property, including but not limited to entrant's computer, which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Giveaway, or from viewing, playing or downloading any material from Sponsor's website(s), regardless of whether the material was prepared by Sponsor or a third party, and regardless of whether the material is connected to Sponsor's websites by a hypertext link.

11. DISPUTES. Entrant agrees that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Giveaway, or any prizes awarded shall be resolved individually, without resort to any form of class action, and solely and exclusively in federal courts located in the City and County of Denver, Colorado or state courts located in Routt County, Colorado; entrant submits to sole and exclusive personal jurisdiction to said courts in

the State of Colorado for any such dispute and irrevocably waives any and all rights to object to such jurisdiction; (b) any and all claims, judgments, and awards shall be limited to actual out of pocket costs incurred, including costs associated with entering this Giveaway but in no event attorneys' fees; and (c) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant or Sponsor in connection with the Giveaway shall be governed by, and construed in accordance with, the laws of the State of Colorado, without giving effect to any choice of law or conflict of law rules of provisions (whether of the State of Colorado, the United States, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Colorado.

By entering the Giveaway, entrants (and, if applicable, their parent or legal guardian) consent to the collection, use and disclosure of their personal information solely for the purposes of administering the Giveaway, in accordance with applicable law.
